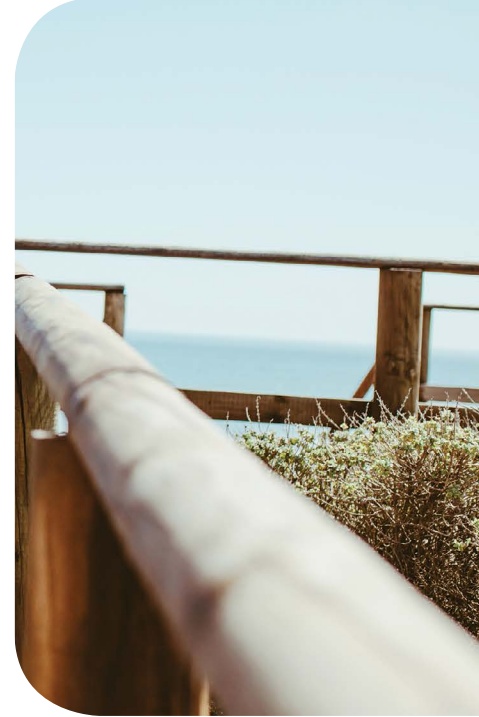

## TRIP CANCELLATION
